

**2022 Income and Asset Guidelines**

To be eligible for financial assistance from Central Vermont Medical Center, your assets and annual income should be at or below the guidelines shown below. Some items such as your primary residence and non-are not considered assets for this purpose. If your income and/or assets exceed the guidelines, but you have extenuating circumstances, an application may be considered when submitted with a letter explaining your circumstances.

**Residency Criteria:** Must be a Vermont resident, or college student who resides in Vermont part-time having lived in our service area greater than 6 months per annum to meet the residency requirement.

In order to manage our resources responsibly and to allow Central Vermont Medical Center to provide the appropriate level of assistance to the greatest number of persons in need, Central Vermont Medical Center has implemented a policy with guidelines to provide assistance based upon a sliding fee scale. Balances after any assistance has been applied shall remain the responsibility of the patient and should be paid promptly.
